1. Call To Order.

Mayor Leonard called the meeting to order at 7:02P.M.

2. Opening Prayer.

RCMP Constable Chet Carol

- Is here to request a letter from the Council to the Air Lines for their assistance in helping to stem the amount of alcohol being brought into the community.
- Do to the limited space in front of Northern he will be going on the radio to ask for people to be patient when the freight haulers are unloading the cargo at the store.
- A comment was that if they removed the snow and pallets from the lot they would have more space to work and not have to block the complete road.

The Honourable Dan Shewchuk was welcomed by Mayor Leonard.

- Minister Shewchuk said he didn't have any prepared speech and was here to listen to the Council and answer any questions he could.
- Councillor Caskey asked what was new for Arviat from Iqaluit.
- Minister said that there wasn't anything new coming forward but he has been

- talking and lobbying for the incinerator along with Mayor Leonard and also for wind power generation.
- He also said that they are looking at making Arctic College in Arviat the centre for the NTEP program for the Kivalliq region.
- Councillor Malla Sr. asked why our MLA did not accompany the C&GS group down to Winnipeg to look at the Incinerator and work to get it for us.
- Mayor Leonard said he would speak on the incinerator in his report.
- Councillor Malla Sr. Stated that Arviat needs jobs. We could get a winter road to Churchill and have everything shipped in here and distribute it overland through the region.
- Minister Shewchuk agreed that Arviat needs jobs and we are working on it. Our Mayor and MLA are lobbying the mining companies as they are now the second largest employer in Nunavut and the GN is the first.
- Councillor Aglukark said that it was a good move by our Mayor to go and look at the Incinerator.

Councillor Savikataaq: the CARs contract has been a problem for years and we have lost money. The motion was passed, Turn it back if there is no agreement by next meeting.

8. Mayor's Comments & Members' Topics & Concerns.

Councillor Ukutak:

- The hamlet has had a lot of snow and the operators have just been piling it up, they should be using the older operators as they know not to pile it at the corners as it blocks the vision of people driving. They should keep the corners open so we can see what is coming.

Councillor Malla:

- We have all this snow and it is making it hard to get out of town. We need a better exit to get out of town.

Councillor Caskey:

- We need a better place for the youth camp and should have it start in Mid June. We need to keep the kids busy all day so that when they go home all they want to do is go to sleep. We should also hire a youth coordinator to develop the programs.

Councillor Savikataaq:

- I will volunteer to find a better site for the Camp, one with sand for a beach area and level so they can have proper facilities and play area.
- We used to get financial reports on what was paid etc. Can this come to council again. That way we knew what was being paid out.

Councillor Aglukark:

- Last meeting we were told about money that hasn't come yet, Hs it come in? Also the ice is thin and we can't take a chance of putting our equipment on it.

SAO responded that the money has started coming in and that we can't put the equipment on the ice as it is to thin this year.

Mayor Leonard:

I was in Winnipeg last week and so I got to go and see the incinerator. The way it works is that everything gets fed into the hopper and is burnt at 1100 degrees. The burn temperature is controlled by adjusting the air dampers. It can also burn stuff with up to a 65% moisture content. The next day the Minister of C&GS and his Deputy Minister and her assistants went out to see it and were real excited and said they would like to put one in Pangnirtung and Pond Inlet. They were asked about Arviat

and said not to worry about Arviat. They also went to see the Thermo Siphon system for artificial ice in the arenas. They said they would like to put this in Clyde River and Pond Inlet. The engineer had the contract to study this for Coral Harbour and Arviat and said they wouldn't worry about Arviat.
