## **Councillor Caskey**

- Complaints from people about the Maguse Road, it is too bumpy, need to have the road graded. Ed replied that we only have one grader and would be too risky to send it out on the Maguse Road, as we need it to service the community first. There's a block of tires put together and will use this to smooth out the road.

## Councillor Aglukark Sr.

-asked if the Hamlet received a letter from the department of Health regarding the H1N1 virus, this is a serious concern -Mayor Leonard replied that he received a call from Alex Campbell about this and was informed that Arviat has not been hit hard with the number of cases -we need to start meeting and start planning for the new 5 year community plan

-a few years ago, our community lost housing units due to lack of land lots, does not want to see this happen again, shortage of housing is very high

## **Councillor England**

-issue of H1N1 virus, need to prepare the community, we should ask the department of health to do a public awareness -last year there was a pilot project done in Iqaluit for recycling pop cans, would like to see this happen here -there is absolutely no GN housing available for new GN employees, this needs to be addressed as we are losing government positions.

-received a letter from Andy Kowtak regarding his contract, requesting for more money to help cover his expenses and asked about a cell phone

-Mayor Leonard suggested that the Hamlet writes a letter to all the businesses for assistance for the security services

#### **Councillor Price**

-concerned about some of the organizations that received bingo slots, have we received an expense report from the organizations? Acting SAO replied that we not have requested any reports but will work on it.

## Councillor Savikataaq Sr.

-the Council does not do the community plan, the Hamlet hires a consultant if the Hamlet is going to get a new building, we should reserve a lot for this building.

#### **Councillor Ukutak**

- -health centre, patient files are confidential and should remain confidential.
- -the acting recreation co-ordinator asked if the arena could get back their internet -there are too many loose dogs, need to get the By Law Officer to work on this

## Councillor Aglukark Brian

-H1N1, agrees with the Council, a public awareness should be done before it breaks out in the community

## **Mayor Leonard**

- --report on his trip to the Agnico-Eagle Mine in Baker Lake. It is a well organized operation. They will be shipping soapstone by barge to Arviat
- -ATV accident recently in the community and would like more information and if there was a By-Law Officer on duty
