RCMP Anthony Egeileh. Discussions:

- Report for month June
- 30% of calls were alcohol related. We are working on the liquor coming into town.
- Some ATV drivers have been out of control during the nights. Has been working nights and seizing keys. Does the Hamlet Council, want us to focus on this issue?

RCMP Marty Viel:

- Thinks it would be best if the RCMP had a liaison with the Hamlet to help with traffic control. We don't want to be giving out tickets but we want compliance.
- Does anybody think people should have to have a licence to drive an ATV? That could take the 14 year olds off the street. Council could make a by-law.
- We've got funds for positive ticketing, so if we see people doing the right thing we will be giving a ticket where they can be entered to win a prize.

Councillor Savikataaq Jr

- From what I see for the dangerous driving, I believe there are only a hand full of people who do it, not everyone.

Councillor Caskey

- Dangerous speeding has been an ongoing problem over the years. You can't chase them and you can't take their ATV's.

RCMP Anthony Egeileh:

- We will start to take their ATV's but the issue with that is; how do I take it, how will I physically take it and after I take it, where will I put it? I will discuss that with the SAO.

SAO:

- I agree there is an issue but I don't want to make changes to our by-law that was made in the 80's or make a new by-law and would like to take a better approach other than licensing.

Deputy Mayor:

- I don't think we will be able to solve this issue tonight as it has been an ongoing issue but we will ponder on it and think of ways we have handle it. I don't think the licencing will work to drive an ATV.

SAO Report:

- Crusher program update, it is up and running, crew is doing an excellent job
- Summer Camp update, 127 kids signed up, camp side is running really well. The issue this year is that the DEA turned us down to use the school and the kitchens in the school which put a tremendous amount of pressure on the program. Right now we're using the kitchen over at the mental health building, making 120 lunches a day and two breaks a day. That's not suitable, the schools being off limits to us and we also asked NAC and they said no as well.

- Last year an issue came up with NHC for filling in lots around the 10 plex and the single dwelling units over on 9<sup>th</sup> and 10<sup>th</sup> avenue. They didn't want spend money to fill their lots. There was an incident where one child almost drowned.

SAO England:

- For the Dion road we received a contribution of \$125,000, so September is when we will get the project started.

Mayor Leonard:

- One of our MLA's told me the other day that he received a letter from CG&S that the school project is going ahead material will start arriving this year.

Councillor Mikeeuneak:

- The subdivision, where the new units are going to be. We should put gravel there for the whole year so it can settle.

Mayor Leonard:

- Some of the areas will be there for a few years before they're built on but they are also starting construction this year.

- Those roads that had the 4 way stop signs near Agnes & Peter Shamee's, did the by-law officers ever tell the public that they were changed around?

SAO England:

- Thank you for bringing that up. I will get the bylaw officers announce it on the radio tomorrow.

Councillor Kablutsiak:

- Would like to notify CG&S for them to install a smaller-mesh fence at the reservoir to keep smaller animals out.

Councillor Caskey:

- Nice to see both garbage trucks being in use and that they're following a schedule.
- Still not happy with calm air, having to go to Rankin first to go to Winnipeg. Winter is coming and it's not going to be fun getting stuck in Rankin.

SAO England:

- Arviat will be hosting a mayors meeting and Hudson's Bay Round Table and that issue will be on the agenda.

Councillor Savikataaq Jr.:

- Would still like to make an Education Committee of Council.
- Would it be possible to shift the by-law officer's working hours later? Instead of working during the day when there is not much action and start late in the afternoon or in the evening instead of early in the mornings.
- The big boat across the RCMP down by the bay, it shouldn't be impossible if we can move it somehow. Get it out of there so kids don't get hurt.
