Public Works Update- Daniel Kablutsiak

- Snow pile Removals, Water and Sewage Services
- Scheduling for season- June to September 2015
- December to February 2015- 18 overflows

Question and Comments to Public Works

Peter Shamee: When it overflows, does the Hamlet pay for damages?

Daniel Kablutsiak: No, Arviat Housing deals with the work. With constant communication between our staff and the Housing staff, all work orders are quickly dealt with.

Nathan Caskey: Regarding garbage, can we have casuals hired to help out with the ravens getting into the garbage before it gets messy. Suggested 2-3 month casual hires to help.

Daniel Kablutsiak: The permanent staff has been divided into "squares" for garbage pickups Rotation of the schedules are done in the evenings, and garbage burning is based on weather. Winds from the south delay our garbage burning.

Jamie Kablutsiak: In regards to snow pile removals, can we contract out the services? Or if we cannot contract out the services, can we hire casuals so that Hamlet benefits from it. Daniel Kablutsiak: We used to contract out the Snow Removal, but we are fully prepared in regards to workloads, heavy equipment, and permanent staff as well as casuals given chance as part of it. At this time, I am currently taking a course online that is work related.

Nathan Caskey: How do you figure out how much power was actually used.

SAO Steve: A formula is used to determine the usage, based on that consumption, a bill is invoiced for the power usage of the month.

8. Mayor's Comments and Members Topics & Concerns

Jamie Kablutsiak: Enquired about street signs, if they could remove them from the buildings, and put them on the actual street signs.

Mayor Leonard: Good discussion about street signs was brought up previously, the signs were pushed or broken down by children, heavy equipment such as loader work or snow piling on or around it. More work to put up signs every year, ordering materials and the shipping costs is why we changed to house numbering.

SAO Steve: At this time, the RCMP has come up with an idea to promote their way of learning street signs. By giving out fridge magnets that states your house/apartment number and the street number as well, it will also include emergency contact numbers.

Uranium mining in Baker Lake – requested 5 representatives for their hearings, has there been anyone picked from Arviat to represent us as Hamlet of Arviat.

Mayor Leonard: We have contacted several people who might be interested in this event, but it is a requirement of staying for 2 weeks, and most people don't have the time from work or home to be away for 2 whole weeks.

Jamie Kablutsiak: Asked if we could offer the summer students a chance to use the crusher this summer by crushing pop cans.

SAO Steve- we are currently working together with the Arctic Co-op in Winnipeg regarding the pop can levy, with an automated crusher. And in regards to having summer students, it could be dangerous to have a student who is not trained in machinery. As well, we have to be careful with Worker's Compensation regulations and policies.

Jamie Kablutsiak: Regarding the graveyard site, there is a metal container that thaws out the ground so it is easier to shovel frozen ground. He said that when they do use the metal container; it leaves a gap or edge around the coffin and the ground. If there is a way to shovel around the gap so that it is easier to lower the casket into the grave. Sometimes a casket is too big or wide to fit into the shovelled area.

Elizabeth U Issakiark: Asked how many times to advertise about the volunteers needed for the Recreation committee.

SAO Steve: You can announce it several times so that local people are aware of the vacancies in the committee boards.

Chris Mikeeuneak: Regarding the Maguse Road, if we could clear the snow earlier this year.

SAO Steve: Daniel Kablutsiak has already planned to clear snow earlier, do some minor road work along the way and then repeat the work in fall time before it snows.

Nathan Caskey: Enquired about the oil drums that were used as storage containers for waste materials from Ennadai Lake, concerned that they might have contaminants in the drums as well as the surrounding areas. We should also clear the area where they store these containers, make sure it is cleared of any garbage, waste materials and cleanup the site as the public uses it as an access area. One of the drums caught on fire and had to be put out.

SAO Steve: I spoke to the foreman who is in charge of the materials and the site; was told that they are only having 7 pieces of material stored. In the past few years, they were given notice of an area where they can store these items properly and given instructions on how to clean up the site. In regards to the fire call, they will be billed for it.

Mayor Leonard: We will contact Alain Chouinard to check the site where they were stored as well as the RCMP as they are trespassing. Also will contact Renewable Resources to check the site if it is safe.

Nathan Caskey: Enquired about the Health Centre front entrance, if they could be contacted to put up stairways alongside the rails on the west side of building. It is getting slippery and has a slope downwards which makes it hard to park for vehicles and elders coming down the slope have hard time reaching the end of the hill.

Mayor Leonard: On behalf of a councillor, raised a concern for the employees or clients. If they could pay for their utility bills by automated system.

SAO Steve: Can look into it sometime in near future, as he is busy now with Year End documents.
