7. Operational Matters and Reports. Senior Administrative Officer

SAO report

- -Lunch tomorrow at the Katimavik suites with the EDO from Val Dor Quebec.
- -The Sao will be going to Rankin for the Meeting with Airports.
- -May have to look at bringing in outside help, we have been trying to get local help but this is not working out.
- -The Accounts Receivable are behind and so we sent out notices with the Water Bills.
- -We are negotiating with the Bank to try and receive interest on our accounts.
- -The line of Credit had been setup as a revolving line, we are getting this changed.
- -We have had some problems with the Accounts Payable double paying, we have that straightened out.
- -We are talking with the Lawyer re: Union Negotiations. We will be doing that the last week of January.
- -Requested that the \$200.00 deposit for Water & Sewer services be approved.
- -Contacted Browning Crocker re: outstanding bills for Water & Sewer services on the Health Centre and ADC offices. They have been contacted and notified of Suspension of Services if not paid.

- -Parts for Furnaces are on their way and should be arriving soon.
- -plaque for Appreciation has arrived and can be given out soon.

Questions to the SAO Report

- -Councillor Caskey Are we to Contract out the Financial Services?
- **-SAO**-Our staff don't have the skills yet and we are working to get them trained.
- -Our AR is behind, I am trying to hire Local but may have to look at flying someone in.
- **Councillor Caskey** Seem like we can't get ahead on the Finances?
- -SAO- the computer has been working well, but one of the problems is that when Chris Rudd did the conversion some of the programs were split up into different accounts and messed up our financial statements. We can't get anyone in until the middle to end of January and I am still looking for help.
- **D/Mayor** Lack of Financial services in town, who are we missing here?
- -SAO-Looked around at who has experienced finance people. Lumber, Housing, GN departments. For most parts all the skilled people are already working.
- **-D/Mayor** Why does our town have a lack of financial professionals? There was a discussion re: lack of training.
- **-SAO** Explained that through it all we are still keeping money in the bank.
- -Councillor Price- We need to find a long term solution for the Hamlet- our current situation is short term.
- **-SAO** We can look at automation for water & sewage and other ways to save money & time.
- -Mayor- We need to work with what we have and look at dividing up job duties. Possibly a reorganization of jobs is needed. Councillor Price- Perhaps a training program would help us.
- **-Councillor Aglukark**-We need to find someone right now, can we find a CA to do what we need?

- **-SAO**-The rates charged by them is anywhere from \$1,000.00 to \$1,500.00 per day. I would like to find someone for around \$500.00 to \$600.00 per day so we will continue to work on a solution.
- -Councillor Caskey- Re: deposits on services, it should be listed that the deposit will be returned.
- **-Councillor Price** Re: Hiring issues on the people from BC re housing.
- -Mayor- I am pretty sure she will be applying for a GN job and get housing.

- Are we planning on fixing up our housing units? We need to evaluate them and decide what we are going to do with them as we will need them to hire people for positions.

Councillor Ukutak

- What happened to the stop sign? The one by the hotel is missing and some in other areas. We should have the bylaw check on them.

Councillor Aglukark-have we heard anything about a visit from the Fire Marshal?

- **SAO-**I tried to contact him but he was off on medical. He is to be in here in January to do training for one week and one week for inspections.
- **D/Mayor** loose dogs are an issue still, bring this up with the Bylaw. What is the status of the O'Briens properties?
- **SAO-**CIBC is trying to get a hold of them through the courts, there is still money owing on the Land Leases.
- Mayor Leonard- I just returned from Agnico-Eagle mine in Mexico where they have 99% Mexican Hires which would be good for us to aim for.
