Councillor Savikataaq Sr:

- Cost of servicing and maintaining furnaces is expensive for the Hamlet buildings
- Diesel pump at the gas station is not working, it must be fixed to provide good service to the community
- Canada Post should hire a person that is bilingual (English and Inuktitut) as the majority of the community is Inuktitut speaking

Councillor Price:

- Are there enough surveryed lots for the next five years
- Alcohol being brought into the community, even though Arviat is a dry community. Action plan is needed by social workers, health workers, wellness worker and the RCMP

Councillor Caskey.:

- Northwestel should be contacted regarding raising the antenna to provide a stronger signal
- Complaints about old existing buildings and vacant housing units, these are a danger and risk for children
- Roads and drainage services, in poor shape and no repairs being done on blocked or twisted culverts

Councillor Ukutak:

- Clean up area at Mikilaaq Lake
- ATV's speeding and parading in the evenings, there is too much speeding and noise level involved
- Local By-Laws have to be reviewed and updated, some existing By-laws are old and outdated

Mayor Leonard:

- Regional Mayor's conference was hosted here last week and it went very well. There were five Ministers from the Government of Nunavut and a Federal Cabinet Minister that attended.
- Metal dump yard clean up, can we request from the Environment

Minister?

Incinerator- we should investigate the pros and cons
